Terms & Conditions

1. If the Seller does not honour this Agreement, the Seller is to refund the Deposit, and compensate the Buyer for any additional cost incurred pertaining to this Agreement.
2. If the Buyer does not honour this Agreement, the Buyer will forfeit 10% of the Deposit.
3. If the Buyer is unable to secure a loan for the intended Loan Amount, this Agreement will be voided, and the Seller is to refund the Deposit to the Buyer, provided the proper documentation are submitted as proof.
4. If this Vehicle is not delivered by the scheduled date, the Buyer has the right to void this Agreement, and the Seller is to refund the deposit and compensate the Buyer for any additional cost incurred pertaining to this Agreement.
5. The Seller is to hand over the keys, remote controls, Owner's handbook, and all other documents which are related to this Vehicle, where available, to the Buyer upon the time of Delivery. The Seller will attend JPJ with the Buyer to officially transfer the ownership at the time of sale.
6. The Seller is to preserve the condition of this Vehicle from the signing of this Agreement and with all accessories intact. In the event that this Vehicle is not preserved in the exact condition as of the signing of this Agreement, the Buyer is entitled to ask for a lower price or void this Agreement. The Seller is to refund the deposit, and compensate the Buyer for any additional cost incurred pertaining to this Agreement.
